Key Points for 2024

Qualifying Grade Point Average

A required Cumulative Unweighted GPA of 3.0 or higher, on a 4.0 scale.

Paid Life Members may record only their PLM Number.

- MCL must record either their Member Number, PLM Number, or Profile Number.

Reminders

- Application due date is **June 1, 2024**.
- **High School students:** Do not submit your application until you have received your *final* high school transcript which indicates your graduation from high school and your final GPA.
- **All Applicants:** Original signatures are not required of the applicant, sponsor, and officers who approve the application. Copies of original signatures are acceptable.
- **Student Data Sheet:** The Student Data Sheet will be posted on the detachment website *after* the preliminary selection of accepted applications is made. That form will be used to provide detailed information so that we can send the scholarship award checks to the proper department at the school.
- **Do not forget the final requirement:** For those who are selected for the scholarship award, you *must* submit a **Confirmation of Enrollment** as a full-time student from the school. Reminders to submit this confirmation will not be sent. Without confirmation, you will not receive the award. Details for submission of this confirmation will be provided to those successful applicants when the preliminary list is posted on the detachment website.

Simpson-Hoggatt Det. 984 Scholarship 2024 Instructions and Application

Please review the new Application and Requirements below carefully.

PURPOSE

To provide a MCL Scholarship to qualified applicants who are pursuing an undergraduate degree or certificate from a technical school or vocational school and will be enrolled as a full-time student (12 semester hours minimum) in the upcoming academic year 2024 Fall Semester and are attending an accredited institution. The MCL Scholarships will only be awarded for a maximum of four (4) * years and must be reapplied for each year. The scholarship does not have to be in consecutive years.

ELIGIBLE RECIPIENTS

1. Paid members of the Marine Corps League (Dues must be current).
2. Spouses, Children, Stepchildren, Grandchildren and Great Grandchildren of paid members of the Marine Corps League.
3. Children of U. S. Marines, FMF Navy Corpsmen and Navy Chaplains serving or who have served with a Marine Unit **.
4. The above students must currently have a **Cumulative unweighted GPA of at least 3.0** on a 4.0 scale.

NON-ELIGIBLE RECIPIENTS

1. Students who already have their first undergraduate degree, are pursuing their second bachelor's degree, are attending graduate school of any kind, or are attending Federal Service Academies are not eligible.
2. Students who do not currently have a **Cumulative Unweighted GPA of at least 3.0** on a 4.0 scale are not eligible.

NON-ELIGIBLE COLLEGES / UNIVERSITIES

The College or University the student plans to attend in the upcoming academic year **2024 Fall Semester**, must be an Accredited Undergraduate Institution listed in College Navigator: (<http://nces.ed.gov/collegenavigator/>) or an accredited vocational institution to qualify for this Simpson-Hoggatt Det. 984 Scholarship.

REQUIREMENTS

APPLICANTS

1. Must have a **Minimum Cumulative GPA (unweighted) of at least 3.0** (on a 4.0 scale).
2. Complete and sign the official 2024 application that is published on the detachment website (Outdated, modified, or incomplete applications will not be approved).
3. If you are both the Applicant and the Membership Sponsor, complete both sections as self.
4. Verify the school you will be attending in the **2024 Fall Semester** is an accredited institution listed in [College Navigator](#).
5. **High School Seniors:** Attach your **Official Complete Final High School Transcript** for all years. Certified copies will be accepted. *The transcript **must** indicate graduation from high school and GPA.*
6. **Current (or former) College Students:** Attach your **Official College Semester Transcripts** for the latest semester completed.
7. Certified photocopies of transcripts are acceptable. Applications and transcripts may be emailed to Simpson.Hoggatt.Scholarship@gmail.com. If mailed, documentation should be sent **Priority Mail or Certified Mail/No Signature Required** to provide a tracking number.
8. Ensure that the sponsor's information is complete, accurate and signed.
9. Ensure that the MCL Detachment Name & Location information is complete and signed by the required (2) Officers.
10. Email the completed Application and all required Transcripts to Simpson.Hoggatt.Scholarship@gmail.com on or before **June 1, 2024**.

SPONSORS

1. All Sponsors membership dues must be paid up to date in the Marine Corps League.
2. **MCL Sponsors** provide all sponsorship data on the application as required, insert their Original League Membership Number on line 17 or their Paid Life Member (PLM) Number on line 18; non-PLM's insert their membership **Expiration Date** on line 18.

NOTE:

- * If the student is enrolled in a program that requires five (5) years to complete then that student will be eligible for scholarship funds in the fifth year.
- ** Proof of service such as DD-214 and honorable discharge will be required.
- *** See your Detachment Paymaster for assistance with these member numbers or expiration date.

CERTIFICATION (By Two Officers) – (Signing Officers cannot be related to the Applicant or Sponsor)

DETACHMENT

1. The Detachment Paymaster will certify on lines 21 and 22 that the Sponsors membership dues are paid up to date.
2. The Detachment Commandant will certify on lines 23 and 24 that the Sponsors membership dues are paid up to date.

NOTE: In the event the Applicant OR Sponsor is related to the Detachment Commandant/Detachment Paymaster, the Detachment “Senior Vice Commandant” will certify in their appropriate lines after verifying that the Sponsor is a paid member in good standing as their “DESIGNEE”. If there is still a conflict the Judge Advocate will sign.

PRELIMINARY APPROVED APPLICATIONS – NAMES WILL BE POSTED TO THE DETACHMENT WEBSITE (WWW.SIMPSONHOGGATT984.COM)

If your application is selected, your name will be posted on or about July 1, 2024, on the Simpson-Hoggatt Det. 984 Website www.simpsonhoggatt984.com, with instructions to obtain an “*Official Proof of Enrollment Letter*” from your school for the 2024 Fall Semester. This “*Official Proof of Enrollment Letter*” and your “*Student Data Sheet*” must include your student ID number and the College/University mailing address which is designated to receive scholarship funds. [Note: The **Student Data Sheet** will be posted on the detachment website along with the names of those whose applications have been preliminarily accepted]. This must be emailed to the Scholarship Committee Chairman no later than August 1, 2024. If the required “*Official Proof of Enrollment Letter*” and the completed “*Student Data Sheet*” are received and the Institutions Accreditation is verified, your name will be submitted to the Detachment Paymaster for issuance of the Scholarship check directly to your college or University..

AMOUNT OF THE 2024 SCHOLARSHIP

The Scholarship Committee cannot establish the amount of the individual Scholarship until August 2024. The amount of the Scholarship can vary from year to year, based on the total number of selected applicants who submit their required “*Proof of Enrollment*” in an accredited institution and “*Student Data Sheet*” to the Scholarship Committee by the deadline of September 1, 2024. The final list of scholarship recipients will be posted on the Detachment Website soon after the September deadline. The Scholarship Committee will then determine the amount of the 2024 Scholarship based on funds available. All recipients will receive the same amount.

IMPORTANT NOTICES

1. All decisions by the Scholarship Committee are final and will not be subject to review.
2. The Scholarship Committee will strictly observe all eligibility criteria and requirements, to ensure compliance throughout.
3. Incomplete applications will not be considered by the committee.
4. **Preliminary Approved Applicants *will not* receive a notification letter. The list will be posted to the Simpson-Hoggatt Det. 984 Website by July 1, 2024.**
5. If you have a change of mailing address or email, notify the Scholarship Committee at Simpson.Hoggatt.Scholarship@gmail.com. If you send scholarship correspondence by mail, you should send via USPS **Priority Mail or Certified Mail/No Signature Required** so you will have tracking number.
6. Documents downloaded from a school website(s) will be accepted if authenticated by that Institution’s Registrar’s Office.
7. Some Institutions may charge a processing fee for ‘Official Documents’ and/or require that the requested Documents be mailed by that Institution directly to the Simpson-Hoggatt Det. 984 Scholarship Committee (see mailing address below).
